INSTRUCTIONS FOR AUTHORS

1."Humans and Nature" is an annual electronic publication series from Museum of Nature and Human Activities, Hyogo ("Hitohaku" as an abbreviation in Japanese). This journal is devoted to the advancement of science in its broadest sense and particularly to the enhancement of forum for the harmonious coexistence of human beings and nature. It publishes original articles, reviews, reports and data. Individual categories are defined as follows:

Original articles: Objective and original reports, whose conclusions are expected to lead to our better understandings in academic sense of relevant subjects.

Reviews: Articles which introduce series of recent findings and relevant discussions in particular fields of science chiefly through bibliographic works from original viewpoints, giving insights regarding crucial problems needing further efforts for solution and directions for future progresses.

Reports: Articles which report preliminary results of field surveys, laboratory experiments, and practical attempts in the places of education.

Data: Articles giving compiled summaries of data obtained by surveys, experiments, tests, etc. These are aimed to be available for future researches, analyses, evaluations, design, etc.

Manuscripts from both inside and outside of the museum are considered as long as their subject falls within the above-mentioned scope, and acceptance or rejection of each manuscript is judged purely on the basis of its scientific merit evaluated through peer-review by two (or more, if necessary,) referees. Manuscripts currently considered for publication elsewhere should not be submitted. Potential contributors and readers are schoolteachers, outdoor-activity-group leaders, community-group coordinators, plus persons handling with practical matter mentioned above in companies, administrative offices, and non-political organizations, as well as professional scientists in the fields of

natural and social sciences. The journal is open-access within the publication lists of the museum

- 2. Only those manuscripts that have been prepared in Japanese or in English with careful attention to the official format of "Humans and Nature" (see below) are to be forwarded to peer-reviews. They should be submitted in electronic form or in triplicate (original and two xerographic copies) with an attached sheet of "Information to Contributor(s)" after this "INSTRUCTIONS FOR AUTHORS" by post-mail. Authors of manuscripts in other languages and those submitting manuscripts electronically are encouraged to contact and consult the Editor-in-Chief prior to actual submission.
- 3. There is no limitation in manuscript length for original articles, reviews, reports and data, although unnecessarily lengthy manuscripts are much discouraged.
- 4. Preparation of manuscripts:
- (a) Manuscript should be typed or printed in double-space on one side of good-quality letter or A4 size papers. Each manuscript page should accommodate 25-30 lines, each encompassing approximately 40 Japanese characters or 80 alphabetical characters per each line, including spaces.
- (b) Arrange sections of the manuscript in the order listed below and number all pages consecutively, including tables and figures, in the upper right-hand corner.

The cover sheet (page 1) should contain: (1) full name, academic affiliation (including post-address), phone and fax numbers, and e-mail address, if available, of the corresponding author; (2) running title with less than 20 Japanese characters or 40 alphabetical characters (including spaces); and (3) the numbers of tables and figures.

The title page (page 2) should contain: title of the paper, and name(s) and affiliation(s) of author(s).

Abstract page (page 3) should contain: (1) lucid digest of the text, not exceeding 400 Japanese characters nor 200 English words (including spaces); and (2) six or fewer key

words, which identify the most important subject covered by a given article, in alphabetical order with a period.

Page 4 plus subsequent pages should contain: text as composed of Introduction, Materials and Methods, Results, and Discussion in order.

Pages immediately following the text pages accommodate acknowledgments and References with the latter listing *all* and *only* of those publications and internet sites referred to in the paper in an alphabetical order of the initial characters of the first authors' family names. Each reference should be given in the following form:

Journal article: Allen, J.C. and Boettcher, A.L. (1978) Amphiboles in andesite and basalt: I. Stability as a function of P-T-fH 2 O-fO 2. *American Mineralogist*, **63**, 1074–1087.

Journal article: Ozaki, M., Matsuura, H. and Sato, Y. (1996) Geologic age of the Kobe Group. *Journal of the Geological Society of Japan*, **102**, 73–83. (in Japanese with English abstract)

Internet site (not preferable): Frost, D.R. (2011) Amphibian Species of the World: an Online Reference. Version 5.5. American Museum of Natural History, New York. http://research.anmh.org/vz/herpetology/amphibia/index.html (latest access: 27 July 2012)

Legends for tables and figures: legend for each table or figure should be prepared so as to enable readers understand meaning of its body without referring to the text; legend for each table should be placed immediately above its body in the same sheet; legends for figures should be grouped in a sheet or sheets different from their bodies.

Figures (including plates): Size of figures as published should be less than 170 mm × 245 mm for a whole page or 80 mm × 245 mm for a single column. Attach an overlay sheet on each photograph. If a scale is necessary, it should be indicated in the figure. When two or more pictures and/or illustrations compose a single figure, they must be mounted on a hard cared board in an arrangement identical to that of final reproduction. Color photographs and illustrations may be published under editor's guidance.

(c) Text references: Citation of a work by one author or two authors in the text should be made, respectively, by giving the author's last name or authors' last names, followed by the year of publication. Give family name of the primary author and use "et al" for the remaining authors when citing a work by more than two authors.

Example:

Noguchi and Tanaka (1966) reported that...

(Noguchi and Tanaka, 1966; Doi, 1968).

Maekawa et al. (1987) stated that...

...(Maekawa et al., 1987).

- (d) Indication(s) of desired position(s) of table(s) and/or figure(s): The place of insertion of table(s) and/or figure(s) in the text should be indicated on the right-hand margin of the manuscript pages.
- (e) Latin names: For the use of Latin names, consult the latest edition of *The International Code of Botanical Nomenclature* or *The International Code of Zoological Nomenclature*. Preferably, each of the Latin names used in an article accompanies the authorship at its first appearance.
- 5. Manuscripts not following the above-mentioned guideline may be returned to the authors without review.
- 6. The Editorial Committee consisting of The Editor-in-Chief and Associate Editors holds the right for final decision regarding acceptance/rejection of each manuscript, for modification(s) in terms of format consistency, verbal accuracy, etc., even after its acceptance, and for the actual arrangement of accepted titles in forthcoming issues.

- 7. Authors should supply their accepted manuscript as formatted text on disk (any IBM compatible or Macintosh format can be handled). It is essential that the hardware and the word processing package are specified on the disk, along with the primary author's surname and the title.
- 8. Proof-reading: Initial version of galley proof of each article will be sent to the corresponding author specified in the manuscript. Since this is the only opportunity of proof-reading for the authors of a given article, they should be sure of checking and correcting all errors on the proof by carefully reading it. However, no changes in the content of the manuscript are allowed at this stage, unless the Editorial Committee agrees and the corresponding author defrays the cost.
- 9. Pdf of each article, published in "Humans and Nature", can be downloaded from the journal site (http://hitohaku.jp/research_collections/bulletins.html) for free of charge.
- 10. Method of initial submission of manuscripts and of their revised versions: All manuscripts should be submitted by registered mail to the Editorial Board of "Humans and Nature", Museum of Nature and Human Activities, Hyogo, Yayoigaoka 6, Sanda 669-1546, Japan. We would like to advise the foreign authors to use EMS or comparable systems.
- 11. Return of original figures after publication: Final versions of accepted manuscripts are to be destroyed immediately after publications of corresponding articles. Upon request by the author(s) at proofreading, however, original copies of figures may be returned.
- 12. Copyright: We consider that submission of a manuscript to **Humans and Nature** means the agreement by the author(s) for the unconditioned assignment of its copyright exclusively to the Editorial Board of "**Humans and Nature**", once it is accepted for publication through peer-reviews. To make digital or hard copies of all or part of "**Humans and Nature**" issues, therefore, written permission must be obtained from the copyright owner in advance by contacting the Editorial Board of "**Humans and Nature**", Museum of Nature and Human Activities, Hyogo, Yayoigaoka 6, Sanda 669-1546, Japan.
